



1. **Region rates per match:**

- a. Provisional Officials \$34.00
- b. Regional Officials \$37.00
- c. Junior National Officials \$39.00
- d. National Officials \$41.00

Boys Far Westerns National Qualifier, Sierra 18's National Qualifier and Girls Far

Westerns National Qualifier pay:

- e. Provisional Officials \$36.00
- f. Regional Officials \$40.00
- g. Junior National Officials \$42.00
- h. National Officials \$44.00

2. **Parking reimbursement:**

- a. Parking will be reimbursed for up to \$20.00 a day.
- b. Hotel parking will not be reimbursed.
- c. Parking receipts are due to assigning@ncva.com by 5:00pm the day after the last day of play. Failure to submit parking receipt on time will result in no parking reimbursement. No exceptions.

3. **Officials per diem:**

- a. Once you complete training and move to Provisional status, you will begin receiving a per diem with your paycheck
- b. \$25.00 a day to everyone no matter what the mileage.
- c. You must work the entirety of each day to receive the per-diem.
- d. You will receive the per diem on your paycheck after the tournament.

4. **Hotel Accommodation:**

- a. NCVA will book rooms for the following events only

National Qualifiers:

- 1. **Boys Far Westerns National Qualifier** December 6-7, 2025.
 - 2. **Sierra National Qualifier** February 28 and March 1st and 2nd, 2026.
 - 3. **Girls Far Westerns National Qualifier** Wk1 April 10-12. Wk2 April 17-19. Wk3 April 24-26, 2026.
- ii. If you travel 50-100 miles you will receive a **shared hotel room** for one night (two days of play), two nights (three days of play).

- iii. If you travel over 100 miles you will receive a **shared hotel room** for two nights (two days of play), three nights (three days of play).
- b. For all other events such as **Power League, Region Championships and Special Tournaments**, we will provide links so that you will be able to book a room at a discounted rate. You are not required to use our link to book.
- c. Hotel rooms will be reimbursed for officials working **all tournament days** in the weekend. Reimbursed up to **\$130.00 a night per room**.
 - i. If you travel 50-100 miles you will be reimbursed for a one-night stay.
 - ii. If you travel over 100 miles you will be reimbursed for a two-night stay.
 - iii. You must submit the hotel confirmation with your name, total cost of stay, number of room nights and the receipt to assigning@ncva.com by 5:00pm of the following day after play. Failure to submit receipt and confirmation number on time will result in no hotel reimbursement. No exceptions.

5. **Girls' Season Bonuses**

- i. Work 6/12 (six out of twelve) Girls League weekends (two full days) and receive a \$300.00 bonus on your last paycheck of the season.
- ii. Work 12/12 (twelve out of twelve) Girls League weekends (two full days) and receive a \$600.00 bonus on your last paycheck of the season.
- iii. **Girls Far Westerns Bonus.** Work all three (3) weekends and receive a \$500.00 bonus!

6. **Payroll:**

Why We Use Work Market:

- a. Provides real-time pay breakdowns after each pay period
- b. Total number of matches worked
- c. Total per diem
- d. Any reimbursed expenses (e.g., hotel, parking, etc.)
- e. Download your 1099 form directly from Work Market (or receive it by mail)
- f. Update or confirm your direct deposit information

Important:

- a. NCVA staff cannot edit your personal information in Work Market
- b. This includes your name, address, SSN, or banking info
- c. Each contractor is responsible for keeping their Work Market profile accurate and up to date

Work Market Account Setup Required

- a. **Link to register:** [Work Market Onboarding](#) (only for new officials who did not officiate in the 24.25 season)
- b. **Verification Time:** Account verification typically takes 2–3 business days, must be fully verified before your first scheduled match.

Pay Periods (Paid Twice a Month):

- a. 5th of each month: Pays for work completed 16th–end of the previous month
- b. 20th of each month: Pays for work completed 1st–15th of the current month
